# Subject:

Mandatory cutter replacement

#### Identification:

Argus Cutter PN# ARG001CUT manufactured for Aviacom SA by Nobel Energetics.

#### Background:

As part of our evaluation program, the Argus was installed in an RTS M7 Mirage and made 46 jumps. Upon opening the reserve container the loop was frayed around the area where it passes through the cutter. The plastic insert was found to be damaged as well.

Any rig, especially those where the cutter is positioned on top of the pilot chute, and with a very small and tight (compressed) reserve container might face the same problem.

Because of this incident Aviacom has redesigned the cutter to eliminate the plastic sleeve in favor of a highly finished metal one. Intensive testing of this new cutter has not identified any further problems. In general the cutter on top of the pilot chute is safer.

#### Service bulletin:

Systems that have the cutter located <u>ABOVE</u> the pilot chute and have the "old style" cutter with the plastic insert, MUST have the cutter replaced with the "new style" cutter before the next jump.

All other systems must have the cutter replaced with the "new style" cutter before the next repack, but no later than June 30<sup>th</sup> 2007.

The 'old' cutter with the plastic insert must be returned to Aviacom SA for replacement. The new cutter will be shipped as soon as we have received the old one.

The new cutter is easily identified by the holographic seal on the body. The date of manufacturing is November 2006 or later.

Any senior or master rigger or foreign equivalent can unscrew the cutter and replace the old cutter with the modified one. The connector must be locked hand tight in order to ensure the water resistance.

# Compliance date:

- Before next jump for all rigs with the cutter located <u>above</u> the pilot chute.
- At the next repack, but no later than June 30<sup>th</sup> 2007 for all others.
