6. Background:

During the yearly inspection of one of the affected emergency parachutes, it has been found that the length of the ripcord between the pins was too large and, in some cases, only one of 2 loops of the parachute could be opened when the manual ripcord was pulled. Subsequent inspection revealed that the dimensions of the static line extension were out of production tolerances.

7. Service Bulletin Procedure:

- a. Affected emergency parachutes send to the manufacturer MarS a.s. for making adjustments.
- b. Manufacturer MarS a.s. makes adjustments as follows:
- replacing one container cover flap without shaping for new cover flap with shaping according to Change No.: 03/22;
- replacing Ripcord with eye for Ripcord with two pins according to Change No.: 03/22;
- replacing Static line with the Extension of Static Line made of Microline cord for Static line with metal ring according to Change No.: 03/22;
